

Declaration – Under 10 Passenger Transportation Vehicle

To use a vehicle with a capacity to carry one to nine passengers, this declaration must be completed and submitted at a ServiceOntario centre prior to providing intercommunity passenger transportation for compensation. The driver of the vehicle identified in this declaration must hold at least a valid class G licence and be at least 18 years of age. This form must also be submitted when a vehicle is exiting the program. An Under 10 (U10) permit is not required for a vehicle to which sections 2, 3, 4 or 5 of *Ontario Regulation 418/21: Passenger Transportation Vehicles* applies.

A U10 identifier will be added to/removed from the vehicle ownership permit once the declaration is processed.

This form will be returned to you once verified and recorded in the system. We recommend that you keep the copy for your records. You will be required to provide details on your Passenger Transportation Vehicle operations to the Ministry of Transportation upon request under *Ontario Regulation 418/21: Passenger Transportation Vehicles*.
