General Conditions for Pilot Participation

I have read and understood the safety and operating conditions in Ontario Regulation 306/15 Pilot Project – Automated Vehicles, as amended, including those listed below:

- Applicant is the owner of the participating automated vehicle(s).
- · Applicant is responsible for:
 - Providing a list of participating vehicles with descriptions (make, model, year, vehicle identification number (VIN) and Society of Automotive Engineers (SAE) level of automation) and notifying the Ministry of Transportation (MTO) of any changes (e.g., vehicles entering and exiting the pilot, changes to automation level).
 - If a list of participating vehicle(s) is not available when applying, it must be provided prior to testing.
 - Specifying the actions, design choices and measures they have taken to ensure the vehicles they plan to test have accounted for cybersecurity risks, as they might impact road safety.
 - Providing MTO with an annual report, including information relating to: unplanned or non-scheduled disengagements
 (can be system initiated or user initiated depending on the circumstances)¹, testing environments, geography/terrain,
 weather conditions, number of km driven, hours tested and speed (km/hr). MTO will provide a template for the report.

Conditions include:

- All *Highway Traffic Act* (HTA) rules of the road and penalties apply to the operation of AVs and subsequent responsibilities of the driver/owner, including collision reporting to police, except where specified in the regulation.
- Testing of automated vehicles will be done safely and in accordance with the HTA.
- Driver must hold a valid licence for the class of vehicle being tested.
- Driver must remain seated in the driver's seat at all times, monitoring the safe operation of the AV, and be capable of taking over immediate manual control. Exception: if the applicant is approved to conduct driverless testing (see additional conditions in Section B below).

- Certify that the motor vehicle(s) is insured under a contract of automobile insurance with an insurance company licensed to operate in Ontario to the limit stipulated in the pilot regulation: \$5 million liability coverage or, if the vehicle has a seating capacity of eight or more passengers, \$8 million. See additional conditions to conduct driverless testing in Section B below.
- Vehicle(s) is prohibited from being used for a MTO road test.
- Reporting a collision involving an automated vehicle to MTO no later than 10 days after the collision.
- As soon as possible notify MTO if testing is temporarily suspended/permanently stopped (for any reason).
- Notify MTO prior to starting testing or resuming testing after temporarily suspended.
- If the contact information on the approved application form changes, please provide the new information to MTO as soon as possible.
- Participants must retain a copy of the application form signed by the Registrar in the motor vehicle(s) being tested at all times.
- Participating vehicles are: in good working order; capable of being driven safely in Ontario; and, meet participation requirements outlined in the regulation.
- Complying with any additional requirements imposed by the Registrar.

Part B – Additional Conditions for Driverless Participation – SAE Levels 4 and 5 Only (Only complete this section if you are applying for Driverless Testing)

I have read and understood the safety and operating conditions in Ontario Regulation 306/15, as amended, including those listed below:

- Applicant declares that the technology is safe and effective based on satisfactory results from prior testing (e.g., closed course).
- Applicant declares the operational design parameters of the vehicle.
- Upon request from MTO, applicant must provide tangible evidence of the vehicle's ability to effectively and lawfully interact with traffic (e.g., through testing video or in-person demonstration).
- Direct oversight function capable of bringing the vehicle to a safe stop (e.g., a trained passenger with access to a switch that stops the vehicle or a remote control and communication link to the vehicle).
- The applicant must declare/specify their direct oversight function fallback to MTO.
- A copy of the application form signed by the Registrar must be retained in a visible location in the vehicle when operating driverless vehicles, as well as by the remote operator.
- In supplement to the application, the applicant will provide to MTO, municipalities (City Clerk) and relevant authorities such as law enforcement and first responders a work zone and law enforcement interaction plan, in writing and prior to testing, explaining how the vehicle will interact with police and emergency vehicles, how the vehicle will react to construction zones and how the vehicle will interact with police and construction personnel on public roads.
- Vehicle(s) to be tested will have signage affixed, at a minimum, to the passenger side of the front windshield and clearly visible on either the rear window or another prominent area on the rear of the vehicle. It is the responsibility of the company to procure their own signs. The design and dimensions are specified in the accompanying information page.
- Applicant will alert the impacted municipality and/or regional municipality in writing prior to testing to advise where the testing
 will take place. We recommend contacting the Municipal Clerk's Office. A list of municipalities in Ontario can be found at the

- If the vehicle is to be tested on a provincial highway, the applicant must seek Ministry of Transportation approval to test by writing to the following address:
