

Completing the *DRC* Return

Debt Retirement Charge Program (*DRC*)

Note: You must still complete and file a return even if no DRC was billed and/or is owing.
Please refer to DRC Guide 106 for further details regarding what to report on each line.

Line 1 - Total kWh Sold or Supplied

Enter the total kWh sold or supplied whether or not DRC was collected.

Line 2 - Total kWh Purchased for Own Consumption

Enter the total of all kWh purchased for own consumption on which DRC was not paid. Include the total kWh of electricity provided to another person at your expense.

Line 3 - Total kWh on Self-generated Consumption

Enter the total of all kWh self-generated and consumed. Include any kWh self-generated and consumed by another person at your expense.

Line 4 - DRC Billed

Enter the total DRC you have billed to your customers whether or not the DRC has been collected. Deduct any refunds to customers and/or bad debt writeoffs.

Line 5 - DRC on Own Consumption

Enter the total amount of DRC payable on kWh reported on line 2.

Line 6 - DRC on Self-generated Consumption

Enter the total amount of DRC payable on kWh reported on line 3. If you have an annual self-generated consumption exemption, DRC is payable on kWh consumed in excess of this exemption.

Line 7 - Total Payment Due

Enter the sum of lines 4 to 6. This is the amount that should appear on your cheque or money order. Payments must be made in Canadian funds drawn on a Canadian financial institution.

Please make your **cheque or money order payable** to the **Ontario Electricity Financial Corporation (OEFC)** and enclose with your return in the envelope provided.

These payments **cannot** be made at a financial institution.
