Instructions and Supporting Documentation

This application form is to be used if you are looking to update your business entity's information during its registration term.

- Your registration must be valid.
- Your registration must not be within 90 days of its expiry date.

Note: If you are looking to update your business entity's information as a part of renewing its registration, please use the **Registration Package for Employers of Security Guards and/or Private Investigators**.

To complete this application, you must:

- Have an existing valid Ontario Registered Employer Private Security and Investigative Services (PSIS)
 Registration Number (not expired).
- Be an authorized representative of the business entity.
- Fill out all applicable fields on pages 3-5.

Note: There is no fee associated with submitting a Change of Information application.

Tip: Use **black** or **dark blue** ink to fill out the application; **if you make a mistake, cross it out**. Write the correct information beside the error and **initial next to it**.

Business Information

Provide the following information on your application (if you are changing or updating any of the following information, please provide both current and new information):

- Legal Name
- Business Name (if name is different from the legal name)
 - A valid Business Name Registration document must be provided if you are adding a new business name or are updating your existing document.
- Ontario Registered Employer Private Security and Investigative Services (PSIS) Registration Number
 - The business entity will have this number if it currently holds an Ontario security guard and/or private investigator registered employer registration.
- Business Head Office Address
- Business Phone Number
- Email Address
 - The business entity must provide an active email address to receive notification of when the application has been completed.

Employee Details

- Details of security guards and/or private investigators that are being added to, removed from, and/or updated in the business entity's list of employees must be provided.
 - The full name (including first and last name), licence number, and licence type must be provided for each employee.

Consent to Collection of Information

Make sure you have read and understood everything in this section. **Print your name**, **sign**, and **date** the application form (date must be within 90 days of submission). Applications that are not signed and dated cannot be processed.

Note: If an application is returned to an applicant due to errors or incomplete information, applicants have 90 calendar days to respond. If the required information is not submitted to ServiceOntario within 90 calendar days, the application is deemed closed. If the information is submitted after 90 calendar days, the applicant is required to submit another application.
