under the Agricultural Tile Drainage Installation Act

To obtain a new Class "C" machine operator's licence, the Regulations under the *Agricultural Tile Drainage Installation Act* indicate that an individual must have "...at least sixty days previous experience in carrying out other duties connected with the installation of drainage works". All operator licences are issued for a three-year term expiring December 31. Fields marked with an asterisk (*) are mandatory.
