Under s. 2 of the <i>Combative Sports Act</i> , S.O. 2019, c. 7, Schedule 9 (the "Combative Sports Act"), the Commissioner is authorized to have the powers and duties set out in the <i>Combative Sports Act</i> and its regulations, including the authority to issue licences in accordance with the <i>Combative Sports Act</i> and its regulations. The Commissioner is responsible for the supervision of professional combative sport contests and exhibitions in Ontario. The personal information collected in this form is necessary to the exercise of the powers, duties, functions and responsibilities of the Commissioner under the <i>Combative Sports Act</i> and its regulations. Your personal information will be used to process your application for a licence, evaluate your eligibility for a licence, administer your licence, if you are granted one by the Commissioner, and for the supervision of professional combative sport contests or exhibitions in Ontario. The authority for the collection and use of any personal information in this form is s. 7 of the <i>Combative Sports Act</i> , 2019 and s. 8(1) and s. 17 of the Regulation (General) under the <i>Combative Sports Act</i> , 2019. The authority for the disclosure of any personal information in this form is s. 46(1) of the <i>Combative Sports Act</i> , 2019 and s. 47 of the Regulation (General) under the <i>Combative Sports Act</i> , 2019.
