

Annual and Semi-Annual Inspection Declaration

The Annual or Semi-Annual Inspection Declaration is used for

- 1) Pick-up trucks and trailers with a registered gross weight over 4,500 kilograms and used for personal use only, or
- 2) The required annual or semi-annual inspection was completed by a Motor Vehicle Inspection Station (MVIS).

This declaration must be completed and submitted to a ServiceOntario centre upon registration or renewal when applicable. Keep this form for your records.
